Kayla helped us understand a little bit more about what she does, she doesn't necessarily sell insurance, but she does sell the service of managing your insurance for you. Kayla mentions what they do specifically For you in pool pact. The pool pact does things such as handling renewal applications, checking for accuracy and organizing the data to get it off to the pool. They do daily service and answering questions. If we need

anything like added vehicles, added changes, certificate request etc. That will all go to the pool they can help anytime and answer any questions for us.

Kayla has also explained they are kind of like a first line of defense, if we have a claim or need help with risk management or anything to do with grants, they are the people we want to get connected with so they can give us all the services that the pool offers.

Marshall Smith- Marshall is the risk manager for the Pool Pact. Marshall explains how pool pact is the carrier that provides that coverage for Round Mountain and 144 other entities in the state, and only public entities only in the state of Nevada.
