**RESOLUTION TO REPEAL THE APPROVAL OF “RESOLUTION NO. 2020-02 A
RESOLUTION OF THE TOWN BOARD OF ROUND MOUNTAIN, NEVADA TO
TRANSFER FROM THE TOWN OF ROUND MOUNTAIN’S GENERAL FUND –
SPECIAL REVENUE FUND – ROAD MAINTENANCE TO NYE COUNTY’S
GENERAL FUND”**

WHEREAS, the Town Board of Round Mountain, Round Mountain, Nevada (the “Board”) is a Town Board organized and operating under the laws of the State of Nevada (the “State”); and

WHEREAS, the Town Board, on January 24, 1995, adopted Resolution 95-01, pursuant to NRS 365.190 the Town receives gas tax revenue and created a special revenue fund, designated as the “Round Mountain Road Maintenance Fund” for the monies collected to be deposited into the Fund; and

WHEREAS, the Town Board, on September 22, 2020, adopted Resolution 2020-02, approved for the Town of Round Mountain to transfer of revenues received from gas tax revenue pursuant to NRS 365.190 to the Nye County’s General Fund; and

WHEREAS, pursuant to Resolution 2020-02 the Town of Round Mountain approved the transfer of revenues received from gas tax revenue pursuant to NRS 365.190 to the Nye County’s General Fund; and

WHEREAS, the Town Board, on October 26, 2021, approved and signed An Interlocal Contract for Use of 1.75 Cents Excise tax and Nye County Resolution No. 2021-XX A Resolution Approving an Interlocal Contract Between the County of Nye and the Town of Round Mountain entitles “Interlocal Contract for use of 1.75 Cents Excise Tax; and

WHEREAS, the Nye County Board of Commissioners, on December 16, 2021, were presented with Nye County Agenda Information Form titles "Discussion, deliberation and possible action to adopt, amend and adopt, or reject Nye County Resolution No. 2021-44: a Resolution approving an Interlocal Contract between Nye County and the Town of Round Mountain established for the purpose of utilizing the 1.75 cents per gallon excise tax on certain motor vehicle fuels which is apportioned to the Town of Round Mountain in accordance with NRS 365.560. This is an existing tax and will not increase the cost of motor vehicle fuel, in which, the item died for a lack of a motion; and

WHEREAS, the Town Board has determined to repeal Resolution 2020-02 and the cooperative agreement with Nye County; and

NOW THEREFORE, THE TOWN BOARD OF ROUND MOUNTAIN, NEVADA, NYE COUNTY, DOES HEREBY RESOLVE AS FOLLOWS:

THAT, Resolution No. 2020-02 Repealed. Round Mountain Resolution No. 2020-02 hereby is repealed in its entirety.
