**RESOLUTION ESTABLISHING SCHEDULE OF MAINTENANCE CHARGES  
FOR WORK PERFORMED BY THE TOWN'S PUBLIC WORKS DEPARTMENT**

WHEREAS, the Unincoeporated Town of Round Mountain ("Town") has acquired and assumed the responsibility for operation, repair, extension and maintenance of the Town's public water and sewer systems ("Systems"); and

WHEREAS, pursuant to the Town's operational policies relating to the Systems, some of the cost of repair, extension and/or maintenance of the systems may or will be billed to persons, firms, corporations, and other private entities requesting or requiring the repairs, extensions or maintenance; and

WHEREAS, the Round Mountain Town Board ("Board") is the governing board of the Town, and is responsible for setting financial policies for the Town, its officials and its employees; and

WHEREAS, the Board finds that in order to fairly and accurately assess to persons or entities their share of the cost incurred, a uniform schedule of charges for equipment and labor should be adopted and used whenever a party other than the Town properly is responsible for the cost of repair, extension or maintenance of the System; and

WHEREAS, the Board, due to its review of the issue, believes that it is in the best interests of the Town and its residents to adopt a uniform schedule of labor and equipment charges for public works jobs which are wholly or partially billed to private parties or entities,

NOW THEREFORE, it hereby is resolved as follows:

1. That the "Schedule for Maintenance Charges for Equipment & Labor Fees" ("Schedule") attached hereto as Exhibit "A", is adopted.
2. The said Schedule shall be used whenever a party other than the Town properly is responsible for, and is billed for, part or all of the cost of a public works job.

**SCHEDULE OF PUBLIC WORKS LABOR AND EQUIPMENT CHARGES**

**LABOR:**

Director of Public Works.....	\$50.00/hour
Maintenance Person I.....	\$30.00/hour
Maintenance Person II.....	\$22.00/hour

**EQUIPMENT:**

Back Hoe.....	\$40.00/hour
Loader.....	\$30.00/hour
Dump Truck.....	\$35.00/hour
Boom Truck.....	\$30.00/hour
Compressor.....	\$30.00/hour
Pavement Saw.....	\$2.00/foot
Sewer Rodder, Cable.....	\$20.00/hour
Sewer Rodder, Sectional.....	\$20.00/hour
Whacker.....	\$10.00/hour
Welder.....	\$10.00/hour
Pick-up Truck.....	\$1.00/mile

3. The Board, from time to time as it deems necessary or appropriate, may make changes to the rates listed on the Schedule for labor and/or equipment charges.
4. A copy of the Schedule, in its current rendition, shall be continuously posted in the Town Offices, for public review and information.
