**RESOLUTION AMENDING THE WATER AND WASTEWATER RATES, CHARGES AND
FEES FOR ROUND MOUNTAIN PUBLIC UTILITY**

WHEREAS, the Town of Round Mountain is the owner and operator of the Round Mountain Public Utility, the provider of water and wastewater services to residents and businesses located within Town limits of Round Mountain; and

WHEREAS, the Town Board of The Town of Round Mountain is charged with the duty and responsibility to establish and set rates for Round Mountain Public Utility; and

WHEREAS, the Town Board may, by resolution, change water and wastewater utility rates, charges and fees; and

WHEREAS, water and wastewater utility rates, charges and fees have not been increased since November 2010; and

WHEREAS, the Town Board has determined that the cost of operating Round Mountain Public Utility have increased such that some of the existing rates, charges and fees for water and wastewater services are no longer sufficient; and

WHEREAS, it is the responsibility of the Round Mountain Town Board to ensure that water and wastewater utility rates, charges and fees are adequate to meet the financial requirements of said utility.

NOW, THEREFORE BE IT RESOLVED that the Round Mountain Town Board does hereby change the following water and wastewater utility rates, charges and fees for Round Mountain Public Utility, effective January 1, 2019.

Sewer Rates – Monthly Flat Rate

Residential \$17.75
Commercial \$23.75

Service Charge

Residential Service Fee ¾" \$ 4.75
Commercial Service Fee 1".....\$ 5.75
Commercial Service Fee 1 ½ ".....\$ 12.75
Commercial Service Fee 2".....\$ 18.75
Commercial Service Fee 3".....\$ 32.75
Commercial Service Fee 4".....\$ 48.75
Commercial Service Fee 6".....\$ 92.75
Commercial Service Fee 8".....\$ 145.75
Commercial Service Fee 10".....\$ 207.75
Commercial Service Fee 12".....\$ 303.75

Other Charges/Fees

Theft/Tamper Fee \$ 100.00 + actual cost of Utility (equipment, repairs, labor)

BE IT FURTHER RESOLVED THAT only the amended rates, charges and fees are listed and that no increase in this resolution shall affect the January 2019 bill that will be generated for December 2018 use.

BE IT FURTHER RESOLVED THAT the Town Manager and Administrative Supervisor for the Town of Round Mountain, are directed to take every step necessary to ensure that the new water and wastewater rates, charges and fees are fully implemented.

BE IT FURTHER RESOLVED THAT, the Round Mountain Town Board and Round Mountain Public Utility recognize that the costs of providing water and wastewater services have increased on an annual basis and anticipate that these costs will continue to increase and therefore may require future increases to water and waste water utility rates, charges and other fees.
