ROUND MOUNTAIN TOWN ORDINANCE NO.93-08

SUMMARY:

An ordinance repealing Round Mountain Town Ordinance No. 90-1 (as amended by Round Mountain Town Ordinance No. 91-1).

TITLE:

AN ORDINANCE PROVIDING FOR THE REPEAL OF ROUND MOUNTAIN TOWN ORDINANCE NO. 90-1 (AS AMENDED BY ROUND MOUNTAIN TOWN ORDINANCE NO. 91-1); PROVIDING FOR THE DISBANDING OF THE ROUND MOUNTAIN PERSONNEL ADVISORY BOARD; PROVIDING FOR THE SEVERABILITY, CONSTITUTIONALITY AND EFFECTIVE DATE HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO.

WHEREAS, the Town Board for the Unincorporated Town of Round Mountain ("Town Board"), pursuant to NRS 269.155 has the power and duty to pass and adopt all ordinances for the Town; and

WHEREAS, the Town Board, on October 9, 1990, adopted Round Mountain Town Ordinance No. 90-1, providing for the establishment of a Town Personnel Advisory Board ("Advisory Board"); and,

WHEREAS, on November 12, 1991, Round Mountain Town Ordinance No. 90-1 was amended by the adoption of Round Mountain Town Ordinance No. 91-1; and

WHEREAS, it is the consensus of the members of the Town Board that the Advisory Board does not provide any appreciable benefit to the residents of the Town; and,

WHEREAS, the Town Board, because of its examination of the issue, is convinced that it is in the best interests of the residents of Round Mountain that the Advisory Board be disbanded and that Round Mountain Town Ordinance No. 90-1 (as amended by Round Mountain Town Ordinance No. 91-1) be repealed.

NOW, THEREFORE, the Town Board of the Unincorporated Town of Round Mountain, Nye County, State of Nevada, does ordain:

TOWN ORDINANCE NO. 90-1 REPEALED. Round Mountain Town Ordinance No. 90-1 (as amended by Round Mountain Town Ordinance No. 91-1) hereby is repealed in its entirety.

PERSONNEL ADVISORY BOARD DISBANDED. From and after the effective date of this Ordinance, the Town of Round Mountain Personnel Advisory Board shall be disbanded. The Advisory Board thereafter will not meet; will have no functions or duties; and shall not take any action.

SEVERABILITY. If any provision of this ordinance or amendments thereto, or the application thereof to any person, thing or circumstance is held to be invalid, such invalidity shall not affect the validity or provisions or applications of the ordinance or amendments thereto which can be given effect without the invalid provisions or applications, and to this end the provisions of this ordinance and amendments thereto are declared to be severable.

CONSTITUTIONALITY. If any section, clause or phrase of this ordinance shall be declared unconstitutional by a court of competent jurisdiction, the remaining provisions of this ordinance shall continue in full force and effect.
