**RESOLUTION OF THE TOWN BOARD OF ROUND MOUNTAIN, NEVADA
TO TRANSFER FROM THE TOWN OF ROUND MOUNTAIN'S GENERAL FUND -
SPECIAL REVENUE – ROAD MAINTENANCE FUND TO NYE COUNTY'S GENERAL
FUND**

WHEREAS, the Town Board of Round Mountain, Round Mountain, Nevada, (the “Board”) is a Town Board organized and operating under the laws of the State of Nevada (the “State”); and

WHEREAS, pursuant to Resolution 95-01 the Town of Round Mountain receives gas tax revenue collected pursuant to NRS 365.190;

WHEREAS, the Board has determined the necessity to transfer from the Town’s general fund, the entire balance of the Special Revenue Fund - Road Maintenance to Nye County’s general fund;

WHEREAS, for the purpose of tracking the revenues and expenditures for the Special Revenue Fund – Road Maintenance pursuant to NRS 365.190, the Board has determined, in order that the financial and other benefits collected on behalf of our taxing district are properly managed, tracked, and expended, the governing bodies of the County and Town have agreed that the County shall provide revenues and expenditures report quarterly, to show residents the monies collected ultimately benefit the town of Round Mountain – Hadley Subdivision;

WHEREAS, the Town Board of the Town of Round Mountain agrees to a cooperative agreement with the County to provide mutual aid for such services of street sweeping and/or snow plowing services in the town of Round Mountain – Hadley Subdivision streets for purposes of maintaining a safe driving conditions for its residents;

WHEREAS, the governing bodies of the County and Town have agreed upon a mutual understanding, in the event the Town of Round Mountain provide mutual aid for street sweeping and/or snow removal, the Town will submit an invoice for such services to the County;

NOW THEREFORE, THE TOWN BOARD OF ROUND MOUNTAIN, NYE COUNTY, DOES HEREBY RESOLVE AS FOLLOWS:

THAT a fund be created and designated as SPECIAL REVENUE FUND – ROUND MOUNTAIN ROAD MAINTENANCE, and

THAT the resources to be used to establish said fund shall come from tax proceeds collected and allocated pursuant to NRS 365.190; and

THAT the purpose of the fund shall be for the following purposes:

1. Maintain, improve, and equip existing infrastructure within the Town of Round Mountain – Hadley Subdivision area;
2. Monies deposited into the Fund be expended to maintain and improve on the streets, alleys and public highways of the Town of Round Mountain – Hadley Subdivision area.
3. Nye County to maintain, improve, and repair the streets, alleys, and public highways of the Town of Round Mountain – Hadley Subdivision area to be in full force and effect from and after approval by Nye County Board of County Commission.
